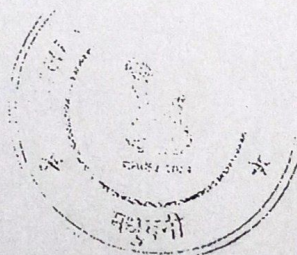

Hereinafter called or referred to as 'Trustees' (which expression shall, wherever the context so admits or requires, be deemed to include their survivors, heirs, executors, administrators, successors, legal representative and assignee) of the Second Part.

Whereas the settler is desirous of establishing a Trust for public charitable objects and whereas the Trustees have, at the request of settler, agreed to act as the first Trustees of these presents as testified by their being parties to and executing these presents. And whereas it is necessary to declare the objects and terms of the public charitable trust, being constituted under these presents.

**Now this indenture witnesseth as follow:**

That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the Trustees, a sum of ₹ 50,000/- (Fifty thousand only) (hereinafter called the 'Trust Fund' with expression shall include cash and any other property or investment of any kind whatsoever in to which the same or any part thereof might be converted, invested or

varied from time to time or which may be acquired by the Trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the Trustees shall hold and stand possessed of the same upon the Trust objects to the powers, provisions, agreements and declarations hereinafter contained.

1. Name The name of the Trust shall be "Vinayaka Foundation" (The Board of Trustees may change it if mutually so decided in future).
2. Registered office : The registered office of the Trust shall be located at Bhagwati Colony, Ward No.- 11, Madhubani-847211 (Bihar) and it can be changed at such other place as the Board of Trustees may decide from time to time.
3. Area of Operation: The operational area of the Trust shall be whole India.
4. Administrative / Branches or Projects offices Trust may have Administrative /Head Office. Branches or Projects offices in such places as decided by the Board of Trustees time to time within the operational area.
5. Funds of the Trust The assets, together with all further donations, contributions, membership fee, Indian and foreign grants, loan, profits and income thereof and the stocks, funds and properties representing the same shall be held by the Trustees upon Trust for the objects and purpose and subjects to powers and provisions hereinafter set out.

## 6. OBJECTIVES OF THE TRUST

Trust will extend its services to 'All round Development of the Society' however it will focus on 'education for all' in general and backward and weaker/disadvantage /socially excluded community including Schedule Caste (SC) and Schedule Tribes (ST) in particular without discriminating caste, creed, race and religion. The integrated objectives of the Trust will be as under:

- 6.1 The trust will work under the components of the Constitution of India. Accordingly it will endeavor to establish and strengthening the democratic value in society. It will provide equal opportunity to all stakeholders of the society without discriminating caste, creed, race and religion. Therefore, the major objective of the Trust will be to strengthening the democratic value in society and try to provide equal opportunity to all citizens, particularly to women belongs to Below Poverty Line (BPL), Dalit, physically challenged persons and socially excluded communities etc.
- 6.2 The slogan of the Government "Education for all" is an important aspect of development of human resources, therefore, it will be one of the important objectives of the Trust will be to provide education, functional literacy to adult, job oriented education to all including women, children handicapped citizens of all other sections particularly disadvantaged groups. Value/ Character/ moral education will be preferred. In this area the Trust will opt innovation in education and conduct research / studies/ evaluation of on going educational structure, Seminar, workshop, Krash School, School under govt. schemes,

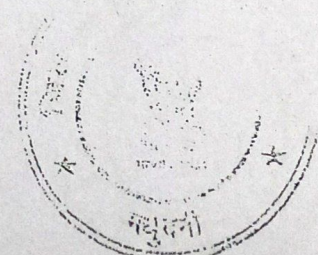

hostels for boys & girls student and working lady will also established etc. as a supportive action of the Government. Urban Slum and Rural areas will be highly preferred. In this direction it will follow the rules and regulations of Central/state government which will be applicable on the Trust. In this light, the trust will also implement schools at different levels as per norms of the government.

6.3 "Health for all" is another important aspect for the government as well as society. Therefore, the Trust will act towards providing support to government efforts and enabling people to get its benefits such as pre/post natal check-up, routine immunization, reproductive health, institutional delivery, HIV/AIDS, Reproductive Track Infection (RTI), Sexual Track Infection (STI) Reproductive Child Health (RCH) and common health and hygiene components. Besides, it will render health services to the society by establishing 'Health Service Centers' in urban or rural areas.

6.4 Agriculture is the base of our nation. So the Trust will work for its betterment through scientific approaches. It will promote to make and use of organic manure and pesticide making through local available resources so that sustainable, eco-friendly and scientific practices could be ensured as to reduce global warming/ climatic change and enrich cultivation / production.

6.5 Its aim to manage human wastage (excreta), animal wastage so that these wastages may be utilized in favors of society and protect the environment. Besides, it will extend its efforts towards encouragement to adopt indigenous agriculture system, plantation and other eco-friendly activities.

6.6 Languages, script art particularly folk arts and crafts are the major things to preserve and promote. The trust will work in this sphere. It will find out the disappearable literatures, scripts, musical instruments and try to preserve these documents / instruments. Besides, it will establish old age home, short stay homes as per government norms.

6.7 The Trust will focus to make researches on different constitutional rights of the people, different acts made by Indian Parliament time to time, environment, educational and socio-economic issues so that new ideas could be brought out through researches which may lead to motivate to policy makers and implementation agencies of the Government for needful actions.

6.8 The Trust will extend relief work and assist to the needy victims during natural calamities / disaster/ accidents and others such as famine, earth quake, flood, fire etc. and to give assistance to institutions or persons engaged in such relief work.

6.9 The Trust will establish coordination with Governmental agencies to implement developmental schemes in the interest of nation at large & to the poorest section.

6.10 The Trust will promote, conduct, undertaken or participate in national and international events, exhibitions, museums, seminars, conferences and conventions. The Trust will also organize such events such as seminar/ workshop/ symposium/ quiz etc among the students, civil societies at national and International level. Besides, it will promote friendship with neighboring countries of India by organizing events as listed above.

6.11 The Trust will engage in promotion of livelihood options to the poor and needy people particularly women and youth, the society will establish cottage industries in rural areas in corporation and support with different Ministries of Government of India and other governmental/semi governmental agencies.

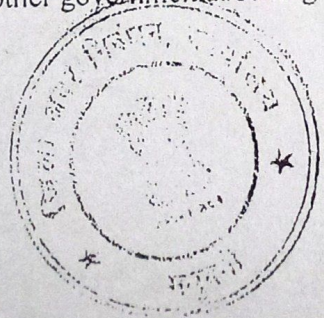

## BY-LAWS OF THE TRUST

### 7. COMPOSITION OF BOARD OF TRUSTEES

7.1

The power of trust would be vested in 'Board of Trustee' (BoT). The Board of Trustee shall have minimum three and maximum nine members having one Settler cum Chairman, Executive Director and maximum seven trustees as member. Settler cum Chairman would be the Chief Functionary of the trust. The Settler cum Chairman will be the permanent member of the trust. The tenure of other members including office bearers would be for three years. In case of death and other causes the post of 'Settler cum Chairman vacant the 'Board of Trustee' will select new 'Settler' among the family of previous 'Settler cum Chairman.'

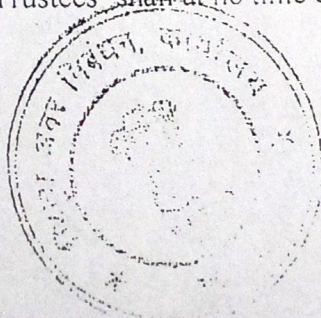

7.2

The first Trustees constituting the 'Board of Trustees' shall have the power to increase the strength of the 'Board of Trustees' but the total number of persons constituting the 'Board of Trustees' shall at no time exceed nine.



7.3 In the event of vacancy in the office of Settler cum Chairman, the board shall elect amongst the family of previous 'Settler cum Chairman through Board of Trustee.

7.4 If any of the time Trustee(s) shall die, or desire to retire, refuse or become incapacitated to act as a Trustee or take the benefit of Insolvency Law, then and in every such case, there shall be vacancy in the 'Board of Trustees' the 'Board of Trustees' may appoint new trustee(s).

7.5 Any trustee may be removed from his post of 'trustee' by 'Board of Trustees' on following grounds-(i) if the trustee becomes unfit or personally incapable to act in the trust; (ii) if found guilty of (a) misconduct or abuse of office, (b) acting dishonestly or fraudulently, (c) misappropriation of trust funds, (d) moral turpitude, (e) application of trust property to private purpose etc. or decision of 2/3 majority of the same.

Besides, the trustee may be removed by a resolution adopted by two-third majority of the members of the 'Board of Trustees' present and voting at a meeting specially called for the purpose. The Trustees affected shall be given reasonable opportunity to cause against the proposed action. However, the decision of 'Board of Trustees' will be the final.

7.6 Vacancies in the 'Board of Trustees' may be filled by the remaining Trustees or outsiders in the meeting called for the purpose. Any trustee may re-elect.

7.7 The quorum for a meeting of the 'Board of Trustees' shall be 1/3<sup>rd</sup> of the existing members. If the meeting has not a quorum within one hour of the fixed time, the meeting shall be adjourned to the same day and time at the same place for the next week. Adjourned meeting shall not require having a quorum.

7.8 The 'Board of Trustees' may meet as often necessary and, in any event, not less than twice in calendar years.

7.9 Decisions at the meeting of the 'Board of Trustees' shall be taken by 2/3 majority of the trustees present by unanimous decision or voting. In the case of tie of votes, the Chairman will cast final and decisive votes.

7.10 Notice shall be served personally or sent by post to the 'Board of Trustees' seven days prior for all type meetings. Notice for emergency meeting would be circulated within 48 hours. The notice would be circulated by letter, or email or mobile phone.

#### 8. POWER AND FUNCTIONS OF 'BOARD OF TRUSTEES:

For the furtherance of the objects of the Trust, the 'Board of Trustees' shall have the following powers and functions:

8.1 To accept any donation, contribution, grant, loan or subscription in cash or kind, from any person(s), body of persons or trust, Govt./ Semi-Govt. department or agency, national or international donor, with or without conditions.

8.2 To apply the whole or any part of the income of the Trust, or the Trust-Fund or accumulations, thereto, to anyone or more of the trust, as the in Trustees may, their discretion, deem fit from time to time

8.3 To convert and deal with the Trust property and/ or any investments for the time being.

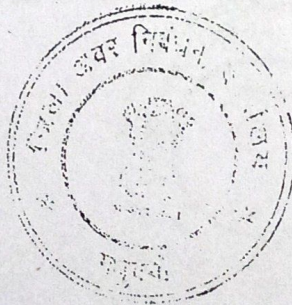

- 8.4 To invest the Trust-Funds either in the purpose the mortgage of immovable property or in shares, stock or in debenture or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the 'Board of Trustees'
- 8.5 To borrow or raise or secure payments of money and also to lend money either with or without security.
- 8.6 To sale, dispose of alienate or otherwise deal with any property comprising the Trust-Funds
- 8.7 To let-out, demise any immovable property comprised in the Trust-Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- 8.8 To adjust, settle, compromise, compound, refer to arbitration all action, suits, claims, demands and proceedings regarding the Trust-Funds.
- 8.9 To appoint or make provision for the appointment of any person for the purpose of the administration of the Trust in such manner and subject to such rule and regulations as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees or hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- 8.10 To, make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- 8.11 To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions or donation made by them.
- 8.12 To set apart and/of allocate the whole or a part of the income of the corpus of trust Fund or part thereof for any of objects of the Trust.
- 8.13 To settle all accents and to compromise, compound, abandon or refer to arbitration any action of proceedings of disputes claim demand of things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- 8.14 To apply to the government, public bodies, urban, local, municipal, district and other bodies, corporation, companies or persons for and to accept grant of money and of aid, donation, gift, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the govt. departments, public and other bodies corporations, companies or persons, schemes and other work and matters within the objects of the Trust and to conform to any proper condition upon with such grants and other payments may be made.
- 8.15 To establish regulate or discontinue branches, centers or project offices within India and or a pointing representative or agents or advisory or agents or advisory committees.

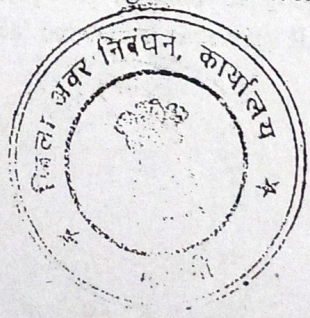

8.16 To subscribe to become a member or otherwise cooperate with any other Trust or its branch whether incorporate or not whose objects are either wholly or in part similar to those of the Trust or which could promoted the interest of the Trust.

8.17 The Trustees shall, from and out of the income realized from the properties, assets and funds other such endowments, end from the Government grants, and from any other sources which they may get, expend such sum or sums of money as they may deem proper towards the maintenance of the properties of the Trust, pay all rates and taxes, pay such sums towards the repayments of any borrowing by the Trustees and meet all expenses which the Trustees may in their discretion think necessary for the proper and efficient managements of the Trust and particular pay the salaries and allowance of all staff and servants, purchase of books, equipments and furniture, pay management contribution for the provident Fund of the staff, gratuity, pension etc. awards, prizes or scholarships to student and incur any other item of expenditure, relating to the institutions, if any under the management of the Trust not hereinbefore specially mentioned, it being understood that the above enumeration gives not priority to any particular item of expense, nor is the same exhaustive.

8.18 No part of the Trust property or its income or any accretion thereto shall be applied for any purpose which is not a charitable purpose in law, and all provision hereof shall be controlled accordingly.

8.19 The Board of Trustee' has management of the affairs of the Trust and overall supervision and superintendence of the Trust and all institutions run by the Trust and all matters incidental thereto.

8.20 No part of the Trust property or its income or any accretion thereto shall be applied for any purpose which is but a charitable purpose in law; and all provisions here of shall be controlled accordingly.

8.21 Any trustee including office bearers and settler may hold any post of trust or its project and can get admissible and modest facilities.

## 9. POWER AND FUNCTION OF 'OFFICE BEARERS OF BOARD OF TRUSTEES'

### Power and Function of the SETTLER CUM CHAIRMAN

9.1 He will Preside all meetings of the 'Board of Trustees.'

9.2 He will take final decision by casting; his vote in case of 'tie' vote

9.3 He will sign on the notice of meetings of 'Board of Trustee' and on proceedings.

9.4 The Executive Director will be the Chief Functionary of the trust and overall responsible for proper functioning of Trust. He will hold control of the functioning of the trust and take any decision related to better functioning of trust or its other activities.

9.5 To take appropriate action as may be necessary to implement the decisions of the 'Board of Trustees'.

9.6 Day -to -day management of the business of the Trust. Convening meeting of the 'Sub Committees' of the trust or project work.

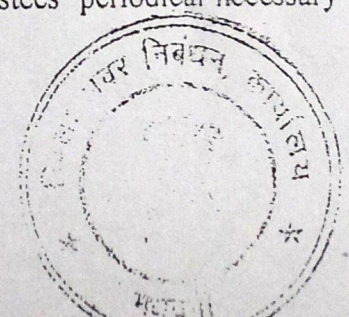

The audit of the accounts will be conducted by the Charter Accountant from any where of the nation.

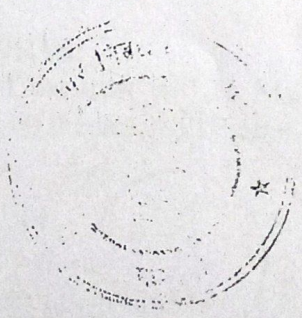

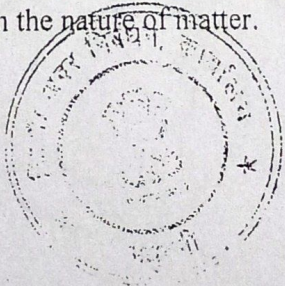
18. JURISDICTION OF COURTS:






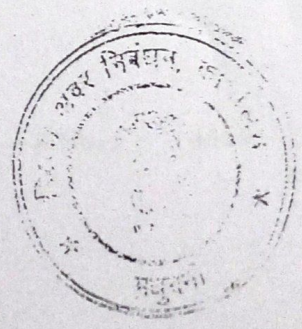
